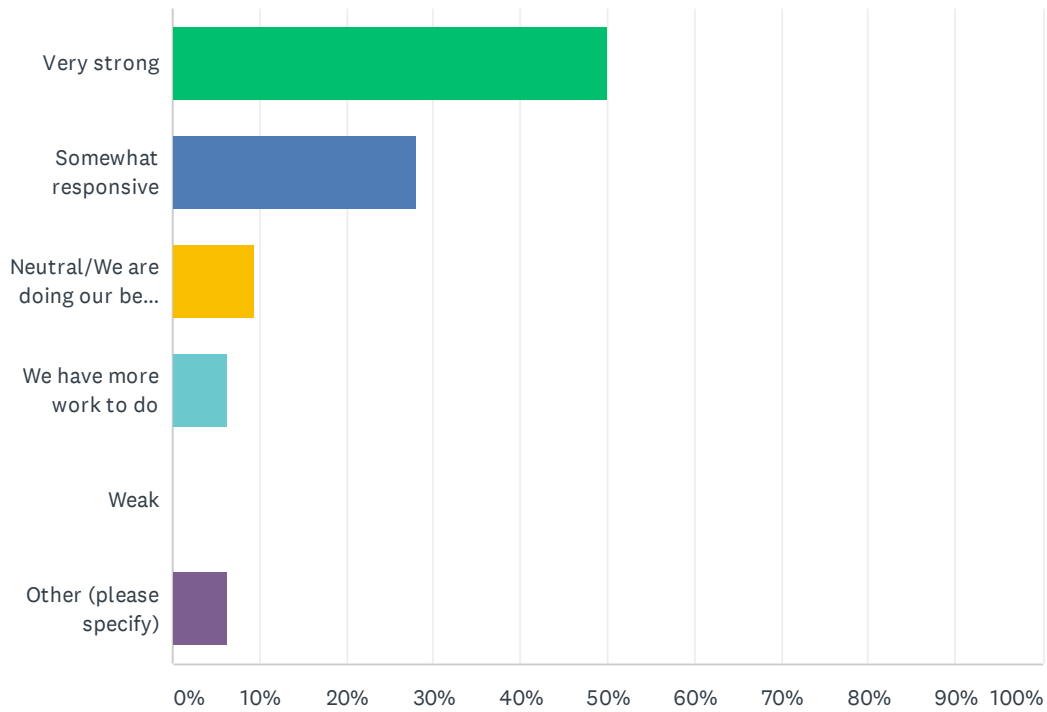


Q1 Overall, how would you rate efforts generally in your community to support businesses and employers through the COVID-19 crisis to date?

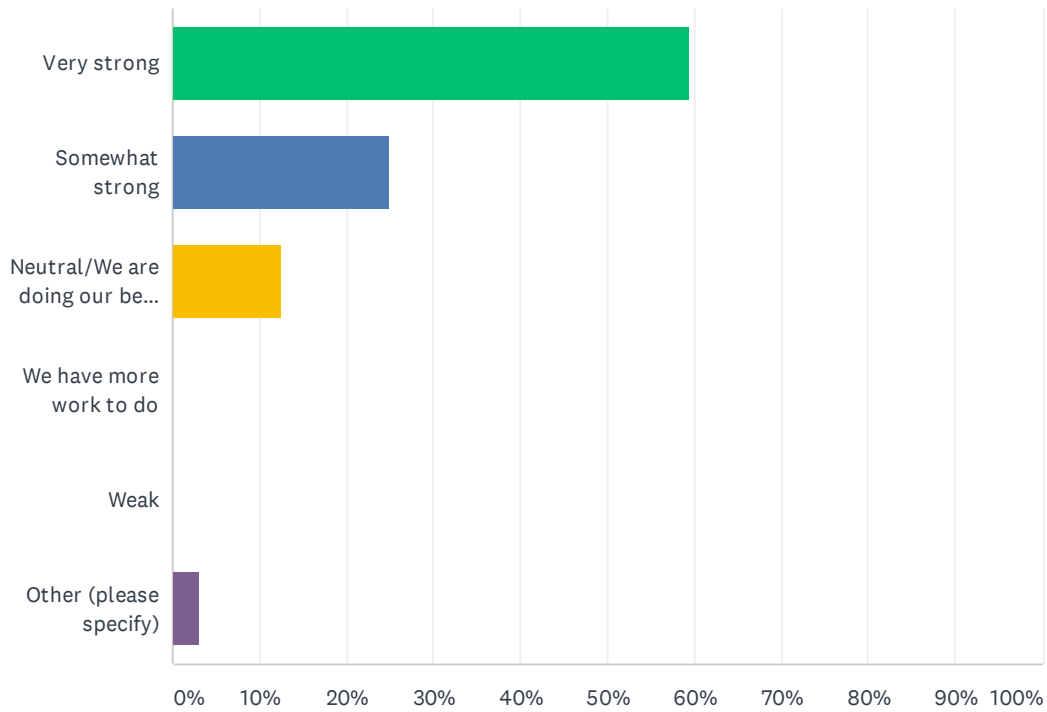

Q2 How would you rate your ADO/EDC's efforts to support businesses and employers through the COVID-19 crisis to date?

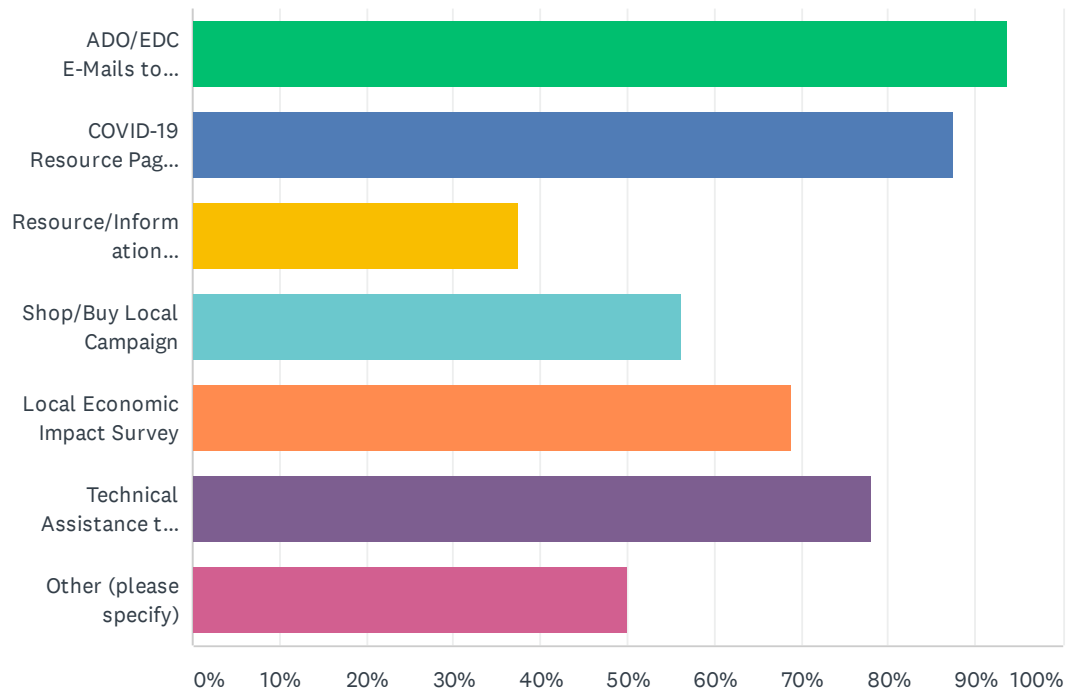

Q3 Which of the following outreach/support efforts has your ADO/EDC employed during the OVID-19 crisis?

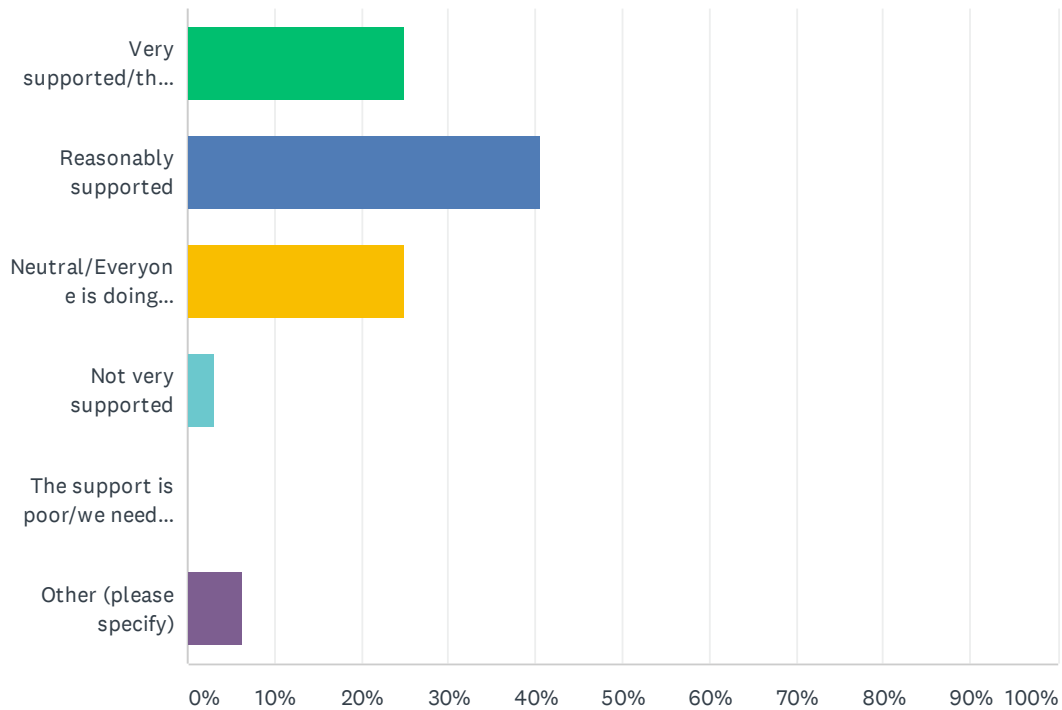

Q4 How supported do you feel by the State and the Department of Commerce through the COVID-19 crisis?

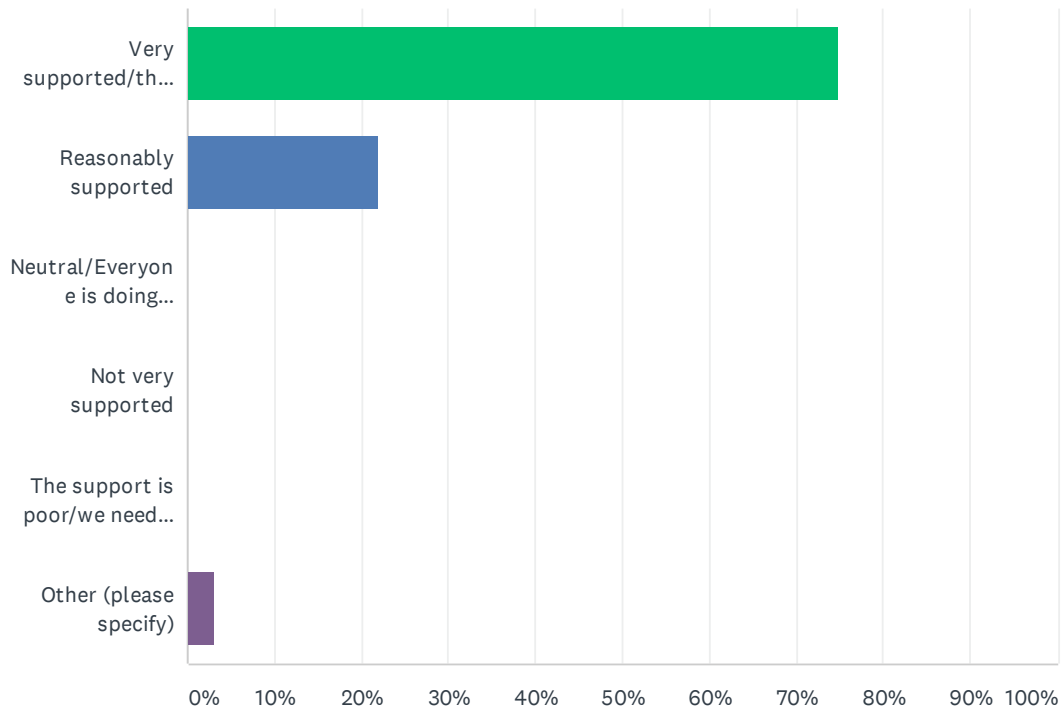
